The meeting was called to order at 1:30 p.m. and roll call was taken.

Boone County Sheriff's Office

1. First and Second Reading: Gasconade County K-9 Maintenance Training Agreement (K-9 Handler Tiffaney Johnson)

Captain Brian Leer stated this is for a dual-purpose dog and, if approved, they will provide maintenance training for the K-9 handler and dog in the areas of obedience, narcotics detection, building search, area search, article search, K-9 aggression control, and scenario-based training. Captain Leer stated the term of this agreement is May 2025 - May 2026 and can be renewed for

two additional terms. Captain Leer stated, if approved, Gasconade County will pay the County of Boone \$2,000.

Commissioner Aldred moved now on this day, the County Commission of the County of Boone does hereby approve the attached K-9 Maintenance Training Agreement between Boone County and the Gasconade County Sheriff.

The terms of the Agreement are set out in the attached and the Presiding Commissioner is authorized to sign said Agreement.

2. First and Second Reading: Gasconade County K-9 Maintenance Training Agreement (K-9 handler Joseph Lynch)

Captain Brian Leer stated this agreement is identical to the last agreement.

Commissioner Thompson moved now on this day, the County Commission of the County of Boone does hereby approve the attached K-9 Maintenance Training Agreement between Boone County and the Gasconade County Sheriff.

The terms of the Agreement are set out in the attached and the Presiding Commissioner is authorized to sign said Agreement.

3. First Reading: Acknowledging receipt of the annual financial statement from the Centralia Special Road District (CSRD)

Boone County Counselor CJ Dykhouse stated, during the month of August, a special road district organized in the County has to report on its financial statement to the County Commission. Counselor Dykhouse stated the Centralia Special Road District is the only special road district in Boone County. Counselor Dykhouse stated all that is required of the Commission is to acknowledge receipt of this information because, if the information has not been received, distributions to the special road district would have to stop.

Commissioner Aldred stated this is a first reading and requested the Deputy County Clerk schedule this item for a second reading at the next available Commission meeting with appropriate order for approval.

Community Services

4. First Reading: Columbia STEM Alliance Contract

Deputy Director of Community Services Kristin Cummins read the following memo:

The Community Services Department requests approval for the Math Mentorship Program with the Columbia STEM Alliance Foundation. The contract was submitted by the Columbia STEM Alliance Foundation as a Strategic Innovation Opportunity to the Boone County Children's Services Fund Board. The contract will pay for academic support and site-based mentoring for math students at Jefferson Middle School and Oakland Middle School. The goal of the program is to increase or maintain academic performance and retention in advanced math classes at two Columbia Public Schools middle schools.

The contract will begin upon approval by the Boone County Commission and extend through December 31, 2025, with the option of two (2) one-year renewals. A total of \$19,998 will be provided through department number 2161 and account number 71106 for the remainder of 2025 and up to \$40,000 for each one-year renewal period. The current fund balance is \$433,332.

Commissioner Aldred stated this is a first reading and requested the Deputy County Clerk schedule this item for a second reading at the next available Commission meeting with appropriate order for approval.

5. First Reading: Award of Contract C001017 from RFP 20-23JUN25 for Videography Services, Term and Supply, to Bussen Productions of Columbia, Missouri, for the Boone County Emergency Management Department

Senior Buyer Liz Palazzolo read the following memo:

Purchasing requests approval for the award of Contract C001017 from Request for Proposal 20-23JUN25 that solicited proposals for Videography Services for the Boone County Emergency Management Department. One proposal was received.

1) Bussen Productions LLC of Columbia, Missouri

It is noted for the record that the RFP was advertised in the Columbia <u>Missourian</u>, posted in the Boone County Government Center Building, and posted online on the County's electronic bidding website, https://bocomobids.ionwave.net/Login.aspx. In addition, Ms. Palazzolo researched local video service vendors and called several when the RFP was first released.

The proposal from Bussen Productions LLC has been reviewed by the Purchasing Department and the Emergency Management Department. Della Luster, Administrative Coordinator for the Boone County Emergency Management Department, and Jacob Waller, Deputy Director of the Boone County Emergency Management Department, reviewed the proposal and found it acceptable. The proposal is responsive to the mandatory terms, conditions and requirements of RFP 20-23JUN25.

As the only responsive proposal, the proposal from Bussen Productions LLC is considered the "lowest and best" proposal. An award of contract for Videography Services, Term and Supply is made to Bussen Productions, LLC of Columbia, Missouri.

Payments will reference: 2702 – Emergency Management Operations/71100 – Outsourced Services with \$20,000 budgeted for 2025.

Commissioner Aldred stated this is a first reading and requested the Deputy County Clerk schedule this item for a second reading at the next available Commission meeting with appropriate order for approval.

6. First Reading: Amendment #1 to Contract C000429 (bid # 17-27OCT20) – Alarm System Equipment & Monitoring Services with Alarm Communications Center, Inc.

Director of Purchasing Melinda Bobbitt read the following memo:

Contract C000429 (bid #2 1-02JUN20) - Alarm System Equipment & Monitoring Services was approved by Commission for award to Alarm Communications Center, Inc. on July 28, 2020, Commission order #331-2020.

Amendment #1 allows equipment other than DMP brand equipment to be invoiced/charged at cost plus 25% mark-up.

7. First Reading: Award of Contract C001026 (10-28MAY25) - Elevator Upgrades and Modernizations at the Boone County Government Center with ATTA Elevators St. Louis for the Facilities Management Department

Buyer Amy Gerskin read the following memo:

Request for Proposal #10-28MAY25 - Elevator Upgrades and Modernizations at the Boone County Government Center closed on May 28, 2025. The County received responses from Otis Elevator, Inc. and ATTA Elevators St. Louis, Inc. The Evaluation Committee for this proposal

included Johnny Mays, Jody Moore, and Michelle Brooks, all from the Facilities Management Department.

After reviewing both proposals and subsequent Best and Final Offers, Facilities Management recommends awarding a contract to ATTA Elevators St. Louis, Inc. for providing the most comprehensive turnkey solution for the County at a cost of \$170,500. The County contract number is C001026. The full evaluation report is attached for reference, along with the evaluation committee's scoring sheet.

Invoices will be paid from department 6200 - Capital R&R - General account 60200 - Equipment Repairs / Maintenance.

Commissioner Thompson moved now on this day, the County Commission of the County of Boone does hereby approve a request by Heather Sears for a conditional use permit for a kennel

and pet boutique in the Agriculture 2 (A-2) zoning district on 10 acres located at 8875 S. Smith Hatchery Rd., subject to the following conditions:

- 1. No dog breeding or training is allowed on the property.
- 2. No outdoor dog runs or kennel structures. Outdoor use is limited to supervised exercise.
- 3. A Landscaping Plan must be submitted to and approved by the Director of Resource Management. Landscaping shall screen the exercise area from adjacent properties.
- 4. A maximum of seven dogs are permitted on the property at any one time. Up to nine dogs are allowed on the following days:
 - A. The two days before and after the major holidays of New Year's Day, Memorial Day, Independence Day, Labor Day, Veteran's Day and Christmas Day.
 - B. Thanksgiving to the Sunday after Thanksgiving.
 - C. The week of the University of Missouri's Spring Break.
- 5. An animal waste management plan, aligned with industry best practices, must be submitted to and approved by the Director of Resource Management before operations begin.
- 6. A Missouri-licensed design professional must coordinate with staff to determine any required modifications to the residence for code compliance. All work must be permitted.
- 7. A subsurface onsite wastewater system is required for the property while the kennel operates. Installation is subject to the Director of Resource Management's approval.
- 8. Only immediate family members residing on the property may be employed in the dog boarding operation. No outside employees are permitted.
- 9. Exterior lighting shall be shielded and directed inward and downward to prevent glare to neighboring properties. Dark Sky compliant fixtures are recommended.
- 10. The owner may use magnesium chloride as an alternative material for dust control on the driving and parking surfaces. It shall be applied as necessary to minimize dust with a minimum of one application per year.
