Purchasing requests approval for Amendment #3 to Contract C000990 awarded from Boone County RFB 18-19MAY21 for Check Point Firewall Support. The contract is with Alecto, LLC, D/B/A Enterprise Consulting Group of St. Louis, Missouri, originally established July 6, 2021, through Commission Order 271-2021.

Amendment #3 adds hardware and software upgrades including maintenance and support to the County's firewall. The total for the upgrade is \$66,567.27.
