The meeting was called to order at 9:30 a.m. and roll call was taken.

Employee Recognition Committee

1. Boone County Employee of the Second Quarter

Kelle Westcott presented the nominees for employees of the Second Quarter

Commission

2. Proclamation Recognizing August as National Emergency Management Awareness Month

Commissioner Aldred read the following Proclamation:

- Whereas, emergencies and disasters can occur unexpectedly, posing significant threats to life, property, and the environment; and
- Whereas, emergency managers on all levels and across all sectors, community leaders, local and state government officials, and the Federal Emergency Management Agency (FEMA) dedicate countless hours to developing preparedness, response, recovery, and mitigation programs to protect the lives and property of all persons in the United States and U.S. territories; and
- Whereas, emergency managers across the United States and U.S. territories are charged with establishing and maintaining the capabilities necessary to effectively direct, coordinate, and support emergency and disaster response and recovery efforts; and
- Whereas, the mission areas of prevention, protection, mitigation, response, and recovery align with the core capabilities identified in the National Preparedness Goal; and
- Whereas, emergency managers serve the nation by responding to countless emergencies and disasters each year, demonstrating commitment, compassion, and professionalism in protecting the public; and
- Whereas, through community outreach, emergency managers empower individuals and groups by providing education on prevention and preparedness, helping to increase awareness, reduce vulnerabilities, build resilience, and create a culture in which preparedness is embedded; and
- Whereas, emergency management is also bolstered by citizens who become part of their local Community Emergency Response Team (CERT), a volunteer program which trains participants about core disaster preparedness and basic response skills, enabling them to aid family members, neighbors, or coworkers immediately following an emergency until responders arrive; and
- Whereas, the efforts of our nation's emergency managers have helped millions of community members across the United States recover, rebuild, and become more resilient in the face of adversity.
- Therefore, in appreciation for the diligent work of emergency managers across all sectors, especially those in the Boone County Office of Emergency Management, to prepare, protect, and serve our communities in the face of hazards and disasters, the County Commission of the County of Boone does hereby proclaim the month of August as National Emergency Management Awareness Month in Boone.

Health Department

3. First Reading: Nuisance Abatement: Parcel #17-315-12-01-065.00 01

Environmental Public Health Specialist Meena Namburi stated the following: a citizen complaint was received regarding this property on April 22, 2025. Ms. Namburi did an initial inspection and sent a notice of violation to the owner by certified mail on April 24, 2025, with return receipt requested. On June 29, 2025, the letter was received unsigned. On July 10, 2025, a violation was posted in the newspaper. On July 28, 2025, a reinspection was conducted and the violation was still present. On July 29, 2025, Ms. Namburi contacted VOSS Landscaping for an abatement quote.

Commissioner Kendrick stated this is a first reading and requested the Deputy County Clerk schedule this item for a second reading at the next available Commission meeting with appropriate order for approval.

Boone County Prosecutor's Office

4. First and Second Reading: Application for the STOP Violence Against Women (STOP VAWA) Grant for 2026-2027

Prosecuting Attorney Roger Johnson stated this is for a renewal of their STOP VAWA Grant. Prosecutor Johnson stated, this year, based on the award opportunity, they are asking for funding for an additional prosecutor in the domestic violence area. Prosecutor Johnson stated that domestic violence cases make up the highest volume of their trial cases and they have already reached a record number this year.

Commissioner Aldred moved now on this day, the County Commission of the County of Boone does hereby approve the application for the STOP Violence Against Women (STOP VAWA) Grant for 2026-2027 submitted by the Boone County Prosecuting Attorney's Office.

Boone County Emergency Management

5. First and Second Reading: 2025 Emergency Management Performance Grant (EMPG) Application

Director of Emergency Management Chris Kelley stated this grant is a 50% match for hourly wages for three FTEs, including his salary, the Deputy Director's salary, and the Administrative Coordinator's salary. Director Kelley stated, without benefits, the total comes to \$129,725.23. Director Kelley stated they are asking for Commission to approve the application for the 50% match. Director Kelley stated they are on a tight deadline to get the paperwork back to the Missouri Department of Public Safety State Emergency Management. Director Kelley stated this request has been awarded in the past and, if awarded again, will get them through the next budget year of 2026.

Commissioner Thompson moved now on this day, the County Commission of the County of Boone does hereby approve the attached 2025 Emergency Management Performance Grant (EMPG) Application submitted by the Emergency Management Department.

Commissioner Kendrick stated this is a first reading and requested the Deputy County Clerk schedule this item for a second reading at the next available Commission meeting with appropriate order for approval.

14. First Reading: Budget Amendment - Department 1243 - JJPA Mental Health Grant

Court Administrator Derek Hux stated this grant is to reimburse Boone County for services provided by mental health providers to youths incarcerated at JJC.

Commissioner Kendrick stated this is a first reading and requested the Deputy County Clerk schedule this item for a second reading at the next available Commission meeting with appropriate order for approval.

15. First Reading: Budget Amendment - Department 1243 - DYS Probation Services Grant

Court Administrator Derek Hux stated this grant reimburses Boone County for the payroll of two FTE positions (DJO) in the Juvenile Office.

16. First and Second Reading: Application for the STOP Violence Against Women (STOP VAWA) Grant for 2026-2027

Court Administrator Derek Hux stated it is time to renew this grant. For the Court, the funds cover the Batterer's Intervention Coordinator and the grant fees help supplement the Batterer's Intervention Program costs for the participants. Mr. Hux stated they use a sliding scale and then the Court gets the 25% match needed for this grant from those participants.

Commissioner Thompson moved now on this day, the County Commission of the County of Boone does hereby approve the application for the STOP Violence Against Women (STOP VAWA) Grant for 2026-2027 submitted by the Boone County 13th Judicial Circuit Court.
